

Dahlgren Township April 8, 2024 Monthly Meeting

The Dahlgren Township Board of Supervisors met for a monthly meeting at the East Union Lutheran Church Parish Center on April 8, 2024. Present were Supervisor Brian Gennrich, Supervisor Keith Kooiman, Treasurer Doran Brahee and Clerk Mary Olson. Also attending were Dan Wellens, Mike Coleman, Dan Groen, Ron Bray and Wayne Lindquist.

Supervisor Kooiman called the meeting to order at 7:00pm.

The Meeting Minutes were typed and emailed out to Board Members. On Motion by Supervisor Gennrich, Seconded by Supervisor Kooiman to approve the meeting minutes. Vote-aye-all-approved.

Wayne Lindquist:

- Mr. Lindquist stated that he had a plat from 2003 that showed that the property line actually goes down the center of the existing cartway. He was going to go to the County with the information. He also again stated that he doesn't think one resident should be allowed to put dust control down on their cartway when the other 4 residents do not want dust control. The Board stated that it is the Township's policy to allow residents to participate in the dust control program that the Township currently has.

Dan Wellens:

- Dan Wellens (14015 County Road 43) requested a variance to relocate his business to the property on County Road 43, it would be at 475' instead of the required 500' setback. On motion by Supervisor Gennrich and seconded by Supervisor Kooiman to approve setback variance. Vote-aye-all-approved.

Road Report:

- Augusta Road – Laketown and Dahlgren Township received a LRIP Grant to repair Augusta Road. A Joint Powers Agreement and a Feasibility Study Resolution needs to be approved by all three supervisors. Since Chairman Thompson was not in attendance, a special meeting will be held on April 17, 2024 to approve.
- The dust control rate for 2024 will be \$.90/foot. The Clerk will email the residents.


