

## **Dahlgren Township April 10, 2023 Monthly Meeting**

The Dahlgren Township Board of Supervisors met for a monthly meeting at the East Union Lutheran Church Parish Center and on a conference call phone line on April 10, 2023. Present were Chairman Jeff Thompson, Supervisor Brian Gennrich, Supervisor Keith Kooiman, Clerk Mary Olson and Treasurer Doran Brahee. See attached attendance sheets.

Chairman Thompson called the meeting to order at 7:00pm.

The Meeting Minutes were typed and emailed out to Board Members. On Motion by Supervisor Kooiman, Seconded by Supervisor Gennrich to approve Meeting Minutes. Vote-aye-all-approved.

### **Augusta Ball Club:**

- Augusta Ball Club requested approval for a Liquor License for the softball tournament on June 2-4, 2023 and a liquor and gambling license for the 52 Club raffle being held on October 7, 2023. On motion by Chairman Thompson and seconded by Supervisor Gennrich to approve the requested licenses. Vote-aye-all-approved.

### **Chairman Thompson requested that the following statement be included in the minutes:**

Statement of support and confidence in our clerk Mary Olson

“Mary has been elected the town clerk for several terms. During her tenure as clerk, she has shown to do her job with the utmost integrity, dedication and always in a thoughtful manner. She has guided the board through all the paperwork that was involved in receiving the federal Covid monies. Runs our elections. She consistently makes sure the board is aware of any and all meetings and upcoming business. She excels at her role of supporting the supervisors and the treasurer.

She has my full support and confidence.”

### **Ron Olson:**

- Ron Olson requested a setback variance for a feedlot at 6975 Inwood Road. The request is for 320 animal units.
  - Tracy Marks, as spokesperson for the neighbors, asked that the Board not to approve the variance request.
  - Other members of the audience stated that the Board approve the variance, but add stipulations to it, such as only beef cattle.
  - Motion by Chairman Thompson and seconded by Supervisor Kooiman to table the discussion until Ron Olson presented a formal application from the County. Vote-aye-all-approved.



### Road Report:

- The box culvert on Maplewood Road will be replaced in 2024. The County will be working with the Township on this project.
- Road Contractor Agreement – On motion by Chairman Thompson and seconded Keith Kooiman to approve the contract with Ron Olson Construction for the 2023 calendar year. Vote-aye-all-approved.
- Dust Control – On motion by Chairman Thompson and seconded by Supervisor Kooiman to accept the quote from Quality Propane at \$1.035/gallon, plus 4% fuel charge. Vote-aye-all-approved. Motion made by Chairman Thompson and seconded by Supervisor Kooiman to raise or lower the rate charged to residents after the Clerk compares last year's rate. Vote-aye-all-approved.
- Road inspection is scheduled for April 21, 2023, meeting at the Clerk's home at 4:00 pm.

### Other Business:

- Resolution (106-23) was presented to allow Supervisors to perform misc. Township services, such as picking up garbage on roadways, removing trees, etc.. On motion by Chairman Thompson and seconded by Supervisor Gennrich to approve the resolution. Vote-aye-all-approved.
- Matt Dunn asked if the County could use the Township minutes instead of returning to another Township meeting and complete the County Recommendation sheet. The Board stated that would be okay to use the minutes.





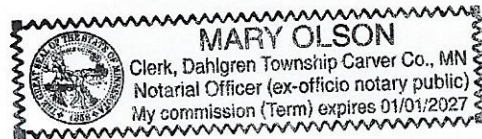
**Claims Approval:**
