

Dahlgren Township July 12, 2021 Monthly Meeting

The Dahlgren Township Board of Supervisors met for a monthly meeting at the East Union Lutheran Church Parish Center ^{M.O.} ~~and on a conference call phone line~~ on July 12, 2021. Present were Chairman Jeff Thompson, Supervisor Paul Modeen, Supervisor Brian Gennrich, Clerk Mary Olson and Treasurer Doran Brahee. Also present were John P. Fahey, Mike Coleman, Mark Willems, Ron Olson and Corey Olson.

Chairman Thompson called the meeting to order at 7:00pm.

The Meeting Minutes were typed and emailed out to Board Members. On Motion by Supervisor Gennrich, Seconded by Supervisor Modeen to approve Meeting Minutes. Vote-aye-all-approved.

Township Land:

- The Township attorney said that the Township could sell the land without public input or notice since the Township owns the property in fee. Chairman Thompson state he has no opinion either way about selling and Supervisor Modeen and Gennrich stated they would sell if the price was right. Chairman Thompson will reach out to Ken Hitzeman to see if he wants to make an offer on the land.

Westbrook Church

- Westbrook Church emailed plans to the Board showing where the driveway would go and where it could connect to Guernsey Avenue. Chairman Thompson will contact the County and make sure that the old Guernsey Road was abandoned. The Church will asphalt Guernsey Avenue from their driveway to County Road 11, the Board will discuss at a later meeting the maintenance of the asphalt section of road.

Road Report:

- Mailbox has been repaired on Kreekwood Road and a new mailbox has been ordered for 130th Street.
- Thistles were mowed on Sara Lane.
- Supervisor Gennrich and Modeen will compile a list of trees that need to be trimmed in the right-of-ways in the Township. They will then contact the affected residents to notify them that the trees will be trimmed. A tree trimming company will then be contacted to do the trimming.
- Dahlgren Road (asphalt section west of County Road 43) needs some asphalt patching. Supervisor Gennrich will contact Wm. Mueller & Sons to get a quote for the work.



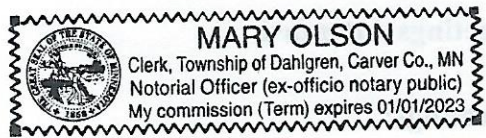
On Motion by Supervisor Gennrich, seconded by Supervisor Modeen to adjourn the meeting at 8:30 pm. Vote-aye-all-approved.
