

MARCH 10, 2026

The Annual Town Meeting held for the Township of Dahlgren, in the County of Carver, and the State of Minnesota, at the East Union Lutheran Church Parish Center, 15180 Co. Rd. 40, Carver, MN, on this date, March 10, 2026 was called to order by Clerk Mary Olson at 7:00 P.M., followed by the Pledge of Allegiance to the Flag.

Clerk Olson then called for a Moderator nominee. On motion by Keith Kooiman and seconded by Doran Brahee to have Mark Willems serve as Moderator. Vote-aye-all-approved. Mark Willems was nominated as moderator.

First order of business: Minutes were typed and given out before the meeting and on request by township residents to dispense with the reading of the minutes. On motion by Doran Brahee and seconded by Norm Glock to approve the minutes as typed. Vote-aye-all-approve.

Due to time constraints, Commissioner Fahey gave an overview of County Road Projects taking place in the County.

The Financial report was given and on motion by Keith Kooiman, seconded by Mike Coleman, to approve the report. Vote-aye-all-approved.

Appeals and Equalization: The Appeals and Equalization process was discussed. No change to the process.

Fire Protection: On motion by Jeff Thompson and seconded by Theresa Willems to leave the fire coverage for Dahlgren Township with Cologne and Carver.

Road and Bridge:

- 2025 road repairs – no comments
- 2026 road projects – culvert/bridge replacement on Maplewood Road over Bevens Creek.

Levy for 2027: The motion was made by Ron Olson and seconded by Jeff Thompson to raise the levy from \$375,000 to \$425,000 for 2027. The decision was made due to upcoming increases in fire equipment/vehicles for both fire departments serving the Township. Vote-aye-all-approved.

Burning Permits will be available on-line and from Mary Olson and Brian Gennrich.



Other Discussion:


- The Dahlgren Township picnic will be held on August 16, 2026 at the Augusta Ball Park.
- Tim Eiden thanked the Township Board for their help in moving the power line from crossing his property and to go along Kelly Avenue instead.


There were 15 (including members of the Board) in attendance at the meeting.
