

## MARCH 14, 2017

The Annual Town Meeting held for the Township of Dahlgren, in the County of Carver, and the State of Minnesota, at the East Union Lutheran Church Parish Center, 15180 Co. Rd. 40, Carver, MN, on this date, March 14, 2017 was called to order by Clerk Mary Olson at 7:00 P.M., followed by the Pledge of Allegiance to the Flag.

Clerk Olson then called for a Moderator nominee, Lori Cox was named Moderator.

First order of business: Minutes were typed and given out before the meeting and on request by township residents to dispense with the reading of the minutes. On motion by Rich Buetow and seconded by Ron Olson to approve the minutes as typed. Vote-aye-all-approved.

The Financial report was given and on motion by Mark Willems, seconded by Doran Brahee to approve the report. Vote-aye-all-approved.

Fire Protection: On motion by Mark Willems and seconded by Paul Modeen to continue with the City of Carver and the City of Cologne for fire protection. Vote-aye-all-approved.

Police Protection: On motion by Ron Olson and seconded by Jack Murphy to not hire any extra police protection. Vote-aye-all-approved.

### Road and Bridge:

- Road repairs that were done in 2016 were discussed.
- 2017 road repairs that were discussed were:
  - Maplewood Road from County Road 43 west to Inwood Road – replace culverts and reshape ditches
  - Inwood Road (south of Juliet) – replace culvert under the road and reshape culverts.
  - If time and funds permit – Maplewood Road from County Road 43 to County Road 40 – reshape ditches.
- Dust control to stay at 1/3 coverage paid by Dahlgren Township and 2/3 coverage paid by the resident and applied twice during the summer. Dust control will also be applied on high traffic intersections within the Township, on motion by Mike Coleman and seconded by Dorene-Murphy. Vote-aye-all-approved.

Levy for 2018: After much discussion on future road repair projects, the motion was made by Mark Willems and seconded by Terri Nelson to change the levy to \$300,000 for 2018. Vote-aye-all-approved.


Burning Permits will be available on-line and from Gene Miller and Mary Olson.

The next Annual Meeting will be on the second Tuesday of March of 2016 (March 13, 2018), starting at 7:00 P.M. at the East Union Lutheran Church Parish Center. On motion by Mark Willems and seconded by Ron Olson. Vote-aye-all-approved.


