The Dahlgren Township Board of Supervisors met for a monthly meeting at the East Union Lutheran Church Parish Center and on a conference call phone line on May 8, 2023. Chairman Thompson called the meeting to order at 7:00pm.

The Meeting Minutes were typed and emailed out to Board Members. On Motion by Supervisor Kooiman, Seconded by Supervisor Gennrich to approve Meeting Minutes. Vote-aye-all-approved.

Steve Follet (Homeland Builders):

- Mr. Follet requested a driveway permit for a property off of Maria Lake Road. On motion by Supervisor Gennrich and seconded by Supervisor Kooiman to approve the permit. Vote-aye-all-approved.

Ron Olson:

- Ron Olson requested a setback variance for a feedlot at 6975 Inwood Road. The request is for 320 cattle (steers, feeders, calves) animal units.
 - Dan Person, representing the residents, requested a denial of the feedlot from the Board. Mr. Person presented a letter to the Board and then highlighted the reasons to deny the feedlot variance.
 - More discussion was held, both for and against the feedlot.
 - On motion by Supervisor Kooiman to have no restrictions on what type of animals or the number of animal units. Motion did not pass.
 - On motion by Chairman Thompson to restrict the number of animal units to 320 and only cattle. Motion did not pass.
 - On motion by Supervisor Gennrich to limit the number of animal units to 194 and only cattle, no hogs. Seconded by Chairman Thompson. Voting as follows:
 - Chairman Thompson – Yea
 - Supervisor Gennrich – Yea
 - Supervisor Kooima – Nay
 - Motion passed

Road Report:

- The old section of Highway 212, now called, Herb Farm Court, will be crack sealed and seal coated. The Board will notify the County that it does not need to put line markings on the road.
- Gravel hauling is scheduled for May 15, 2023
- Dust Control – Quality Propane will contact Supervisor Kooiman with the date for putting down dust control.




Claims Approval:
