John Egan gave the following update on property taxes for Dahlgren Township:

- In 2024, residential properties had an increase of 3.71%
- In 2024, agriculture properties had an increase of 12.01%
- In 2024, commercial properties had an increase of 1.74%
- The overall increase was 7.18%
- The Department of Revenue also increased their Green Acres and Ag Preserve Values
 - o Tillable values went from \$8,300/acre to \$9,500/acre.
 - o Non-tillable went from \$2,700/acre to \$3,100/acre
- 2024 Dahlgren Township Average Single Family home value is \$598,700
- 2024 Dahlgren Township Median Single Family home value is \$552,600

 - o In 2024 the bulk of the construction will by at the Bongards crossing
 - Estimated completion date is 2026

Road Report:

- 177 loads of redrock was hauled on the roads
- Dust control is scheduled to go down the week of May 20, 2024
- Augusta Road (the townline section) a meeting was held with Laketown Township to approve the Feasibility Study. The Study was approved and a public meeting will be held on June 6, 2024 at the Laketown hall.
- Guernsey Avenue: The Township received two quotes to reclaim the section of Guernsey Avenue from the intersection of Hampshire Road, north to Glens Road and patch the potholes north from Big Woods Blvdl, north to Hampshire Road. Allied Blacktop quote was \$41,472.00 and GMH Asphalt quote was \$39,975.00. On motion from Super visor Kooiman and seconded by Chairman Thompson to accept the GMH Asphalt quote with the contingency of clarification on the items not included in the quote for saw cutting and removals. Vote-aye-all-approved. Also, work cannot start until the Township receives a Certificate of Insurance.
