

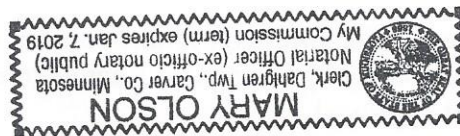

On motion by Supervisor Buetow and seconded by Supervisor Miller to accept the election results. Vote-aye-all-approved.

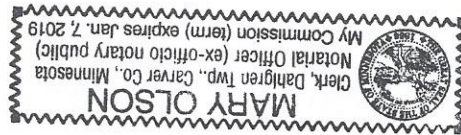
