- Augusta Road: The Township received the Joint Maintenance Agreement with Laketown Townshp for Augusta Road. The Township Board has no changes to the contract but requests that a map be included as Appendix A, showing exactly where each Township maintains which sections of Augusta Road. Chairman Thompson will contact the County for a map. Discussion tabled until the next meeting.
