### Road Report:

- The Engineer looked at the asphalt project on Glen Road, Hunting Avenue and Guernsey Avenue. He made some recommendations and will by onsite when the project starts to make sure everything is to code. The project is scheduled to start in October 2023.
- Chairman Thompson will contact Carver County Soil and Water to schedule a meeting to look at the culvert that goes under Maplewood Road, near Mike Coleman's home.
- Lundquist Cartway a landowner put boulders in the Township right-of-way. The Board will contact the owner to remove the boulders.
- Dahlgren Township road certification. On motion by Chairman Thompson and seconded by Supervisor Kooiman, the Board certifies that the Township has 41 miles of road. Vote-aye-all-approved.
- Maplewood Road Box Culvert Project: Chairman Thompson sent the Township Attorney changes of the Joint Powers Agreement (JPA) to the County for comment. The topic will be tabled until next meeting to discuss any feedback from the County.
