RESOLUTION ESTABLISHING PRECINCTS AND POLLING PLACES

WHEREAS, the legislature of the State of Minnesota has been redistricted; and

WHEREAS, Minnesota Statute section 204B.14, subd. 3 (d) requires that precinct boundaries must be reestablished within 60 days of when the legislature has been redistricted or at least 19 weeks before the state primary election, whichever comes first;

NOW, THEREFORE BE IT RESOLVED that the Town Board of the Dahlgren Township, Carver County, State of Minnesota hereby establishes the boundaries of the voting precincts and polling places as follows:

Precinct 1 (East Union Luther Church Parish Hall, 15180 County Road 40, Carver, MN 55315)

All of Dahlgren Township not included in Precinct 2

Precinct 2 (East Union Luther Church Parish Hall, 15180 County Road 40, Carver, MN 55315)

All of Section 1, Township 116 North, Range 24 West, Carver County, Minnesota.

AND

The Northeast Quarter of Section 2, Township 116 North, Range 24 West, Carver County Minnesota.

AND

The Southeast Quarter of Section 2, Township 116 North, Range 24 West, Carver County Minnesota.

AND

That part of the Northwest Quarter and that part of the Southwest Quarter all in Section 2, Township 116 North, Range 24 West, Carver County Minnesota, lying easterly of the following described line:

Commencing at the northwest corner of the East Half of said Northwest Quarter; thence North 89 degrees 24 minutes 06 minutes East, along the north line of said East Half of the Northwest Quarter, 287.77 feet to the point of beginning of the line to be described; thence South 45 degrees 30 minutes 56 seconds West, 63.86 feet; thence South 51 degrees 06 minutes 47 seconds West, 130.33 feet; thence South 54 degrees 58 minutes 51 seconds West 136.88 feet; thence South 42 degrees 12 minutes 40 seconds West, 32.04 feet; thence South 17 degrees 02 minutes 55 seconds West, 28.24 feet; thence South 7 degrees 12 minutes 15 seconds West, 49.27 feet; thence South 7 degrees 02 minutes 47 seconds East, 147.36 feet; thence South 5 degrees 37 minutes 20 seconds East 136.70 feet; thence South

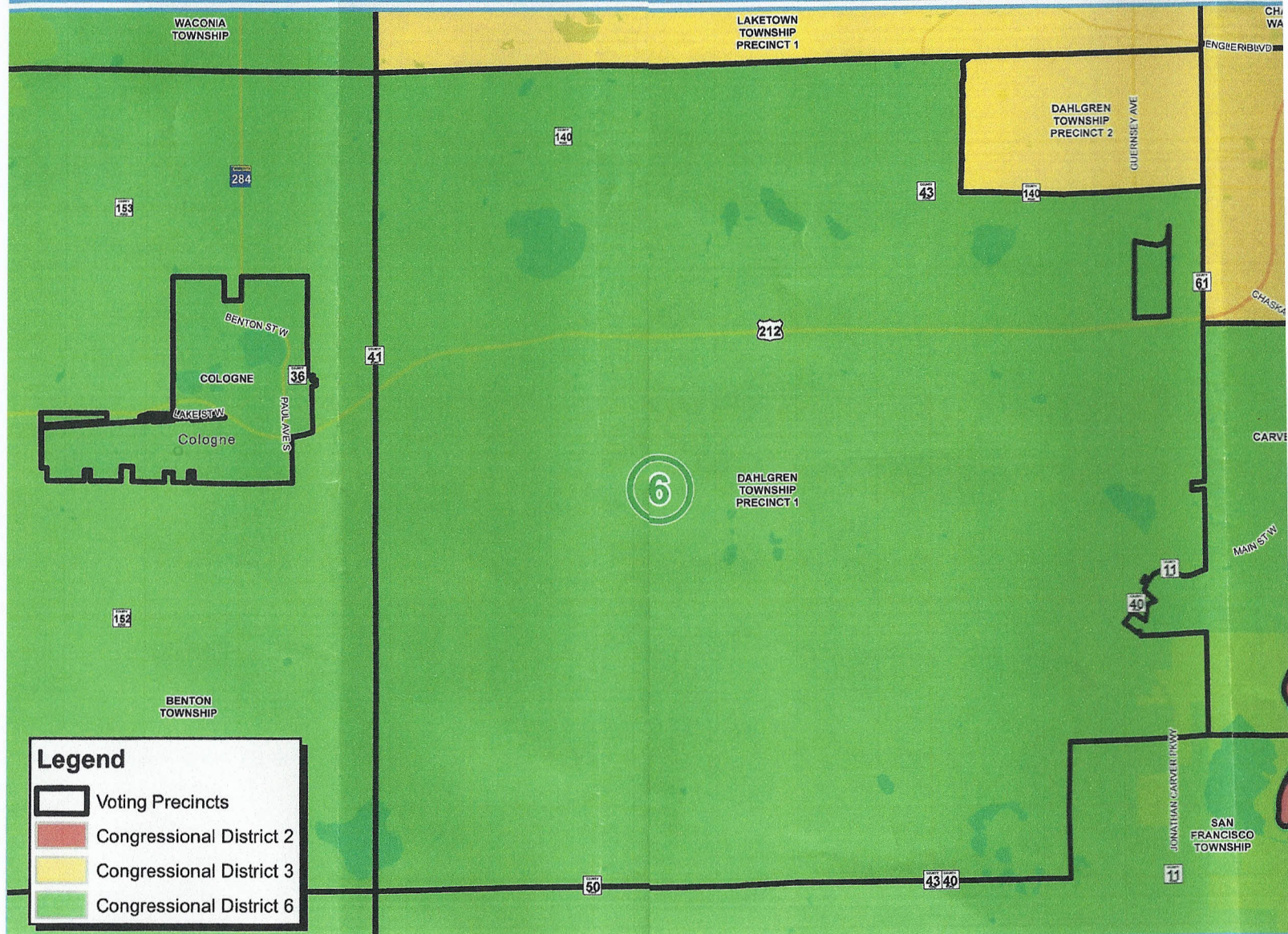

Dahlgren Precincts & Congressional Districts

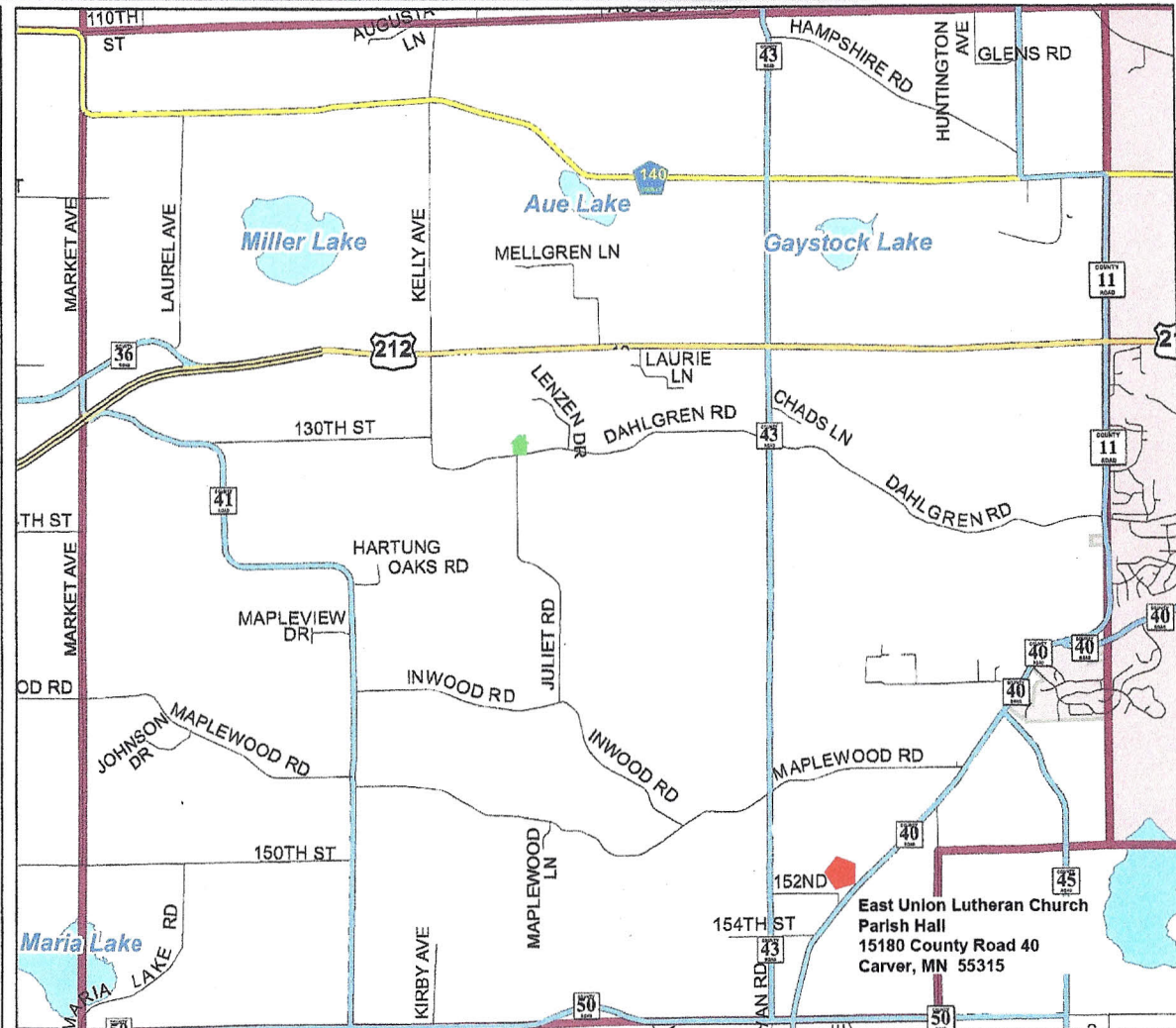


Dahlgren Township Polling Place Location
